## **INSTRUCTIONS FOR USE**

- Apply liberally and evenly to all unprotected areas of the skin 20 minutes before sun exposure. Re-apply every 2 hours or more often when sweating and after swimming or towelling.
- Always wear protective clothing, hats and eyewear when exposed to the sun.
- · Avoid prolonged exposure to the sun.
